

R 400.8143(6) Children's records.	Three children did not have health appraisals/record of physical evaluation on file with restrictions noted by the physician within 30 days of enrollment. One child's health appraisal was missing the exam date.	Program director Ms. Wright will obtain health appraisals from the families of the children missing them and ensure all health appraisals are complete. If parents do not provide a completed health appraisal, their children will be excluded from care.	By 12/18/2022

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
