R 400.8112(2)(f)	There are three individuals that aren't listed on the staffing plan connected in CCBC.	I will disconnect people who are no longer staff members from CCBC. I will be sure to disconnect employees that decide to leave the day after they no longer are employed.	1/12/23
R 400.8128	Two child care staff members did not have TB test results on file.	I have already contacted the health department and will have both in their files as soon as possible. I will be sure to	1/20/24

		have a checklist in each file and have everything completed within the hiring process.	
R 400.8131(2)	I reviewed five child care staff member's files. Of the five, four of them did not have safe sleep training.	I will have each staff member complete the Safe Sleep Training within the next two weeks. In the future, I will add this to my staff training list as it was a mistake on my behalf believing it was included in the mail MiRegistry Health and Safety Training.	1/24/24
R 400.8122(9)	Verification of the education, credentials, and experience of each lead caregiver was not be kept on file at the center or at MiRegistry.	Sarena is currently working toward her lead teacher credentials. We will add her CPR, hours, and training (once it is completed) once she returns from her accident.	1/24/24
