IV. Description of Findings and Conclusions

The terms of the original license have been modified on 9/14/2006, 9/09/2011 and 8/31/2022. Sonshine Kids Preschool opened as a preschool in August 1996. The center added a before and after school program on 9/14/2006. The center discontinued the before/after school component on 9/12/2011. The center increased use space, capacity and added a meal component and full day child care component on 8/31/2022.

The center now has requested a change in ages served from 0-5 to 0-13 to serve school age children during the summer months only. Sonshine Kids Preschool is located in St. Paul Lutheran Church in Coldwater.

The center utilizes the following four classrooms for approved child use space:

- The preschool/school age 1 classroom measures 15 sq. ft. x 39 sq. ft. providing a total of 585 square feet. This allows for a total capacity of 12 children ages 2 ½ to 13 years.
- The preschool/school age 2 classroom measures 20 sq. ft. x 16 sq. ft. providing a total of 320 square feet. This allows for a total capacity of 9 children ages 2 ½ to 13 years
- The preschool/school age 3 classroom measures 19 sq. ft. x 15 sq. ft. providing a total of 285 square feet. This allows for a total capacity of 8 children ages 2 ½ to 13 years.
- The infant room measures 15 sq. ft. x 39 sq. ft. which equals 585 sq. ft. This allows for the total capacity of 11 infants and toddlers ages birth to 30 months. The license understands that two caregivers would be needed in this room if more than four infants/toddlers are present, and three caregivers would be needed in this room if more than eight infants/toddlers are present.

The total approved capacity is 40 children at any one time in the facility ages birth to 13 years. The licensee understands that each room approved

for use has a maximum number of children allowed at any one time, but the overall capacity in the center cannot exceed 40 children. The facility will offer all day programming through the year. The hours of operation will be Monday to Friday from 7:00 A.M. to 5:15 P.M. The program is approved to provide full meal service of morning snack, lunch and afternoon snack, and will use the licensed kitchen of the Lutheran church. The facility has four toilets, two urinals, and four sinks available for the children's use. This supports the centers capacity of 40 children. The classrooms are furnished with a variety of developmentally age appropriate play and learning equipment to support the capacity of 40 children. The room arrangement is conducive to a preschool and infant/toddler setting. A qualified fire inspection was completed on 7/20/2022 with a "C" rating. A reinspection was completed on 8/26/2022 with an "A" rating. An environmental health inspection with an "A" rating was completed on 8/10/2022. A lead hazard risk assessment was completed and passed on 6/15/2016 and included all rooms approved for child use.

V. Recommendation

I recommend changing the age range served to birth to 13 years.
