II. Purpose of Addendum

On 07/13/2022 Licensee designee Amy Scott-Kronemeyer requested that room 17 be added as approved child use space; therefore, increasing the center's capacity to 70 children. Before and after school care was also added for room 17.

IV. Description of Findings and Conclusions

The terms of the original license were modified on 06/08/2018, 03/14/2019, 10/03/2022 and 11/10/2022.

Room 17 was added on 11/10/2022. Room 17 is 25' x 29' for 650 square feet. Room 17 is approved for 16 students over the age of 30 months. There is one hand washing sink in the classroom. Children will use the boys' and girls' bathrooms in the same hallway. The preschool will run 8:00 am – 3:15 pm. There will be before and after school program as well that runs 7:30 am – 5:15 pm. Meals are provided by Soo area public school. Parents will provide transportation.

Room 16 was added on 10/03/2022. Room 16 is 31' x 24'8" for 764.6 square feet. Room 16 is approved for 18 students over the age of 30 months. There is one hand washing sink in the classroom.

Children will use the boys' and girls' bathrooms in the same hallway. The girls' bathroom has two sinks and three toilets. The boys' bathroom has 3 sinks, 2 toilets and 2 urinals.

The original license approved Room 4 for 18 students over the age of 30 months. Room 4 is 28' x 28' for 784 square feet.

Two rooms were added on 06/08/2018. Room 1, also 28' x 28' for an additional 784 square feet, is another classroom. Room 3 is 34' x 36' and will be used for a lunch room with office space available for staff members. Room 3 was not used in determining the center capacity. Room 1 and Room 4 each have a bathroom in the classroom with one toilet and one handwashing sink.

On 03/14/2019, the gymnasium/multi-purpose room is approved for child care use. This room is not used to determine center capacity. It is available to use for the children's gross motor skills during inclement weather.

There is a variety of developmentally appropriate gross motor skill equipment available. The classrooms are furnished with a variety of developmentally appropriate equipment. There is an adequate amount of equipment to support the capacity.


Environmental health and fire safety inspections were completed at the time of original issuance.

A lead hazard risk assessment was completed on 06/27/2014. The following rooms were tested: room 4 and the gym. No lead hazards were found. A lead hazard risk assessment was completed on 09/07/2022. The following rooms were tested: room 16, room 17, room 18, the boys' and girls' bathrooms, room 1 and room 3. No lead risk hazards were found.

Transportation is provided by CLM Community Action Agency for room 16.

V. Recommendation

I recommend room 17 be added as approved child use space; therefore, increasing the center's capacity to 70 children.
