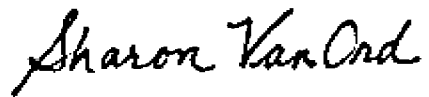

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

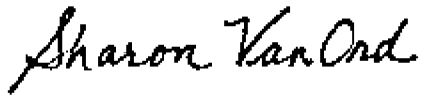
On 04/10/2023 I arrived for the inspection; however, preschool was not in session. Licensee designee and program director Ms. Smith was kind enough to come to the building for me to complete the inspection of the approved spaces, staff paper work, children's files, and outdoor play area. The classroom is well organized and inviting. The center has an abundance of developmentally appropriate equipment for the children to choose from.

On 04/11/2023 I returned to the center to observe staff and children. Children were warm, friendly, and transitioned smoothly between activities. I observed children address conflict with other children appropriately and independently. Child care staff moved around the room, meeting individual children's needs. Staff engaged in play with children and expanded their language skills.

The facility is in compliance with all applicable rules and statutes.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
