This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 09/05/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

When I arrived on-site, child care staff members Ms. Gabrielle Sholtz, Ms. Kim Rooney and Ms. Sarah VanWagoner were present. Lead caregiver Ms. Mandi Bliesener was not present on this day. There were four children in attendance. Three of the children were engaged in free choice time and one infant was engaged in tummy time on the floor. Ms. Rooney was attending to the infant in care, while Ms. Sholtz and Ms. VanWagoner attended to the other children in care. The room is small, but well organized with a variety of toys and equipment for the children to interact with and use. The child care staff members had a good rapport with one another, as well as, with the children in care. The children appeared happy and comfortable within their care.

Hand washing was not observed during this inspection, but it was discussed. None of the children were sleeping at the time of the inspection, but safe sleep rules were discussed.

As a result of the inspection, I did not find any rule or law violations.

Technical assistance and consultation were provided to licensee designee Ms. Janel Boulis for the following rule:

- **R400.8173(1) Equipment.** Ensure that the slide being used indoors by the child care children is being used according to the manufacturer's directions.
