II. Purpose of Addendum

On 08/04/2020, Ms. Stebelton requested a change to the hours of operation from 8:30 AM to 11:30 AM to 08:30 AM to 04:00 PM. During the inspection, it was determined that the capacity for classroom 1 and classroom 5 were inaccurate and the classrooms needed to be measured to determine the correct capacity for each room.

IV. Description of Findings and Conclusions

The terms of the original license have modified on 05/19/2021.

The center is located inside the Petoskey United Methodist Church in Petoskey and in consists of two classrooms and a multi-purpose room.

The following rooms have been approved as child use space and meet the 35 square feet per child requirement:

- **Classroom #1:** This room was measured to be 19.83 ft. x 18.08 ft., plus 8.33 ft. x 9.58 ft., plus 6.25 ft. x 8.25 ft., providing for a total of 490 square feet. This allows for the requested capacity of 10 children 30 months of age and older.
- **Classroom #5:** This room was measured to be 20.08 ft. x 19.83 providing for a total of 398 square feet. This allows for the requested capacity of 10 children 30 months of age and older.

The following rooms are approved as additional child use space and were not used to determine the center's total capacity:

- **Youth Room:** This room measured to be 31.58 ft. x 22.83 ft., providing for a total of 721 square feet. This allows for 20 children 30 months of age and older.

The licensee understands that when there is a mixed age group in the space, the caregiver to child ratio is based on the age of the youngest child in the room. The licensee designee understands that for classrooms with children 30 months to 3 years of age, the maximum group size cannot exceed 16.

The classrooms are furnished with a variety of developmentally appropriate toys, materials, and equipment. There is an adequate amount of equipment to support the center's capacity.

There is a toilet and two handwashing sinks in classroom 1. In classroom 5, there is one handwashing sink. A women's and men's restroom can be found adjacent from the center's classrooms. There are four toilets and three handwashing sinks in the women's restroom. There are four toilets, three urinals, and three handwashing sinks in the men's restroom. There are enough toilets and handwashing sinks to support the center's capacity.

The center was built in 1981 so a Lead Hazard Risk Assessment is not needed. An "A" rated fire inspection was completed on 08/13/2020. An "A" rated Environmental Health Inspection was completed on 02/24/2021. A playground inspection was completed on 04/25/2015.

Terms:

The center operates Monday through Friday during the school year from 08:30 AM to 04:00 PM.


The center is approved for a total capacity of 20 children ages 30 months through 6 years of age.

Parents provide a morning snack, lunch, and an afternoon snack.

Transportation and swimming are not program components.
