Dear Ms. Gallagher:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 03/16/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8112 Comprehensive background check; fingerprinting.

- (2) An applicant or licensee shall do all of the following:
 - (e) Within the department's child care background check system, accurately complete and maintain the connection, disconnection, or withdrawn status of each individual associated with the license.

The background check website had three active child care staff members who were no longer working in the center. I instructed program director Nancy Gallagher to disconnect them from the background check website.

R 400.8131 Professional development requirements.

(12) When the department of licensing and regulatory affairs or the department of education publishes a notice that a new health and safety update document or a new health and safety update training activity has been published on MiRegistry, the licensee shall ensure that all personnel read and acknowledge the document or complete the activity within 6 month of the notice.

Ms. Gallagher acknowledged that the required Health and Safety Refresher training for 2021 had not been completed. I informed her that any child care staff members had to complete the refresher training each year on the www.miregistry.org website. I emailed Ms. Gallagher a cheat sheet with instructions on how to complete the miregistry trainings and the 2021 link for the refresher training.

Violations were identified at the time of the inspection. You have provided an acceptable written corrective action plan.


