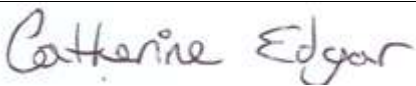

R 400.8315(1)	Each refrigerator must have an accurate working thermometer indicating a temperature of 41 degrees Fahrenheit or below. At the time of the onsite inspection, the new refrigerator in Room 105 was in need of a thermometer.
R 400.8380(1)	The premises must be maintained in a clean and safe condition and must not pose a threat to health or safety. At the time of the onsite inspection, I discussed the storage of plastic kitchen wrap stored under the sink in Room 105.
R 400.8125(3)	All supervised volunteers shall receive a public sex offender registry (PSOR) clearance before having any contact with a child in care. A copy of this clearance must be kept on file at the center.

I discussed printing out volunteer PSOR results as verification that this had been completed.
