II. Purpose of Addendum

The licensee is requesting to clarify use space, and to add Room 314/315 for children 2.5 and older with an increase in the capacity from 120 to 143.

IV. Description of Findings and Conclusions

The original terms of the license were modified on March 23, 2023, February 23, 2021, August 31, 2021, and September 15, 2006.

CenterPoint Child Care is a single-story building located inside CenterPoint Christian Academy. The building consists of 9 classrooms, a gross motor room and a gymnasium. The following classrooms are approved for use space.

- Room A is 29 ft. x 21 ft., providing a total of 610 square feet. This allows for a total capacity of 12 children ages birth to 2.5. This room has a sink that must be exclusively for handwashing purposes. The licensee designee understands that three child care staff members would be needed in this room if more than eight infants or toddlers are present. In addition, the licensee designee understands that they must have one crib for each child younger than 12 months of age in attendance at the center at any given time
- Room B is 21 ft. x 20 ft., providing 420 square feet and the side room is 20 ft. x 8 ft. providing 160 square feet. This allows for a total capacity of 11 children ages birth to 2.5. There is a handwashing sink and toilet connected to both areas. The licensee designee understands that they must have one crib for each child younger than 12 months of age in attendance at the center at any given time. This room has a sink that must be exclusively for handwashing purposes.
- Room C is 25 ft. x 23 ft. providing a total of 575 square feet. This allows for a total capacity of 12 children ages birth to 2.5 years of age. Previously this room was used as a preschool room. If children age 2.5 and above use this space, it can accommodate 16 children.
- Room D is 25 ft. x 20 ft. providing a total of 500 square feet. This allows for a total capacity of 10 children ages birth to 2.5 years of age. This room was previously licensed as a preschool room. If children ages 2.5 and above use this space, it can accommodate 14 children. The licensee designee understands that if there is a mixed age group in this room, that the ratio is

based on the ratio requirements of the youngest child. There is a bathroom that connects Room C and Room D, which has two toilets and one sink.

- Room 305 is 24 ft. x 26 ft. providing a total of 624 square feet. This allows for a total capacity of 18 children ages 2.5 and older. There is an attached playroom which measures 20 ft. x 26 ft., providing an extra 520 square ft. of play space, which will not count in the capacity at the request of the licensee designee. If children ages birth to 2.5 use this space, the total capacity is 12 children. This room has one toilet and one sink attached to it.
- Room 307 is 26 ft. x 20 ft. providing a total of 520 square feet. This allows for a total capacity of 10 children ages birth to 2.5 years. This room was previously used as a preschool room. If children age 2.5 or older use this space, it can allow for a total capacity of 15 children. This room has one toilet and one sink attached to it.
- Room 308 is 26 ft. x 20 ft. providing a total of 520 square feet. This allows for a total capacity of 15 children ages 2.5 and above. If children age birth to 2.5 use this space, it can allow for a total capacity of 10 children. This room has one toilet and one sink attached to it.
- Room 309/310 is 23 ft. x 40 ft. providing a total of 920 square feet. This allows for a total capacity of 26 children ages 2.5 and above. The licensee designee understands that if there is a mixed age group in this room, that group size and ratio will be followed at all times. Ratio is based on the ratio requirements of the youngest child.

The following rooms are approved as additional child use space and are not used to determine the center's total capacity:

- Room E (large gross motor room) is 20 ft. x 28 ft. providing a total of 560 square feet. This allows for a total capacity of 11 children ages birth to 2.5 years of age or 16 children over 2.5 years of age. The licensee designee understands that group size and ratio must be followed at all times. Ratio is based on the ratio of the youngest child.
- The gymnasium is 60 ft. x 90 ft., providing a total of 5400 square feet. Based on 50 square feet per child, this is enough space for a room capacity of 108 children aged birth to 2.5 years at one time. Based on 35 square feet per child, the capacity of this room would be 154 children. If there are children of mixed ages in the same room or well-defined space, then the ratio and group size shall be determined by the age of the youngest child, unless each group of children is clearly separated and the appropriate child care staff member-to-child ratios and group sizes, if applicable, for each age group are maintained.

The total space is sufficient for a total center capacity of 143 children, aged birth to 12 years based on square footage in the center.

There is a total of 18 handwashing sinks, 19 toilets and two urinals in the center. The center utilizes the bathrooms in the hallway, which has a girl's bathroom with four toilets and two sinks. The boy's bathroom has two toilets and two sinks.

In addition, there is a girls bathroom connected to the gymnasium. In the boy's bathroom there are two toilets, two urinals and two sinks. In the girl's bathroom there are four toilets and two sinks.

The hallway near the school side has two bathrooms. There are five toilets and four sinks. The boy's bathroom has three toilets, two urinals and three sinks.

There is a large fenced outdoor play area located behind the building which is utilized for the smaller children. There is a small commercial grade play structure for toddlers. A playground inspection was completed on July 14, 2021. In addition, there is a large grassy area behind the center for the older children. There are currently no play structures being used; the center will provide riding toys, balls, jump ropes, chalk, etc. for outdoor play.

The center provides breakfast, lunch and three snacks throughout the day. The center does not provide transportation or swimming.

An environmental health inspection was completed and approved on July 30, 2021. A school certification signed statement was completed by the school superintendent on August 07, 2021. A lead hazard risk assessment was completed on May 06, 2016.

On December 20, 2022, I inspected Room 314/315. The space is approved as a child use space and will be used for the school age children.

- Room 314/315 is 40ft. x 25ft., providing a total of 1,000 square feet. This space is sufficient for 29 children aged 2.5 -12 years of age.

Terms:

The center is approved for a total capacity of 143 children age birth through 12 years.

V. Recommendation

I recommend the addition of Room 314/315 as approved child use space and a capacity increase from 120 to 143 children, birth through 12 years of age.
