Dear Ms. Gunn:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 12/20/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

**R 400.8335 Food services and nutrition; provided by center.**

- (8) All of the following apply to milk:  
(a) Containers must be labeled with the date opened.

During the inspection, I observed a couple opened milk containers that were not labeled with the date of opening. Ms. Gunn stated that her staff are trained on this rule and must have forgotten. She will remind staff to immediately label the milk once opened.

**R 400.8380 Maintenance of premises.**

- (4) Floors, interior walls, and ceilings must be kept in sound condition, good repair, and maintained in a clean condition.

During the inspection, I observed several of the ceiling tiles throughout the center that had evidence of previous water damage. Ms. Gunn stated that she would have the maintenance man from the church/school replace the tiles. They have several in the building for this. In addition, there was flaking paint on the walls in some of the classrooms where they needed to patch/repair. Ms. Gunn agreed to have these spots repaired as well by January 25, 2023.

During the inspection, I provided Ms. Gunn, technical assistance and consultation on the following rules:


- Maintaining the ccbc background check fingerprint website accurately (I assisted with this while onsite)
- Documenting primary caregiving. This was being done onsite, but not every room was doing this consistently
- Post the current recall list (I emailed the current list on 12/20/2022)
- Posting handwashing/diapering signs at all sinks (fixed onsite)
- Thermometers in fridges (completed onsite)
