This letter is to advise you that the 05/11/2022 corrective action plan you submitted, regarding each rule violation cited in the recently completed Renewal Licensing Study Report, is approved.

| <b>R 400.8112(2)(e) Comprehensive background check; fingerprinting.</b> | At the time of the inspection, the background check website was not being maintained accurately with all current staff. Three currently connected persons were no longer working in the center and 2 new staff were not fingerprinted and connected to the site. | Ms. Thomason agreed to have herself or the school secretary/authorized user maintain the site accurately.  | 05/25/2022           |

| <b>R 400.8131(3)<br/>Professional<br/>Development<br/>Requirements.</b>  | At the time of the inspection, the 2 of the new staff persons did not complete the shaken baby/head trauma training prior to caring for children. | Ms. Thomason stated that she was unaware that staff had to complete this course prior to caring for children and she thought that they had 90 days as part of the MiRegistry requirements. I provided her consultation and technical assistance on this requirement and she agreed to have any new staff take this training before caring for children. | 05/25/2022 |
| <b>R 400.8131(5)<br/>Professional<br/>Development<br/>Requirements.</b>  | At the time of the inspection, the 2 of the new staff persons did not complete the shaken baby/head trauma training prior to caring for children. | Ms. Thomason agreed to have any new staff take this training before caring for children.  | 05/18/2022 |
| <b>R 400.8161(5)<br/>Emergency<br/>Procedures.</b>                       | At the time of the inspection, the fire drills were not completed quarterly since October 2021.   | Ms. Thomason stated that the drills are conducted through the school usually and they might have completed them but she does not always document when they are done. She agreed to do a new drill for this quarter and to perform and document fire drills quarterly as required.   | 05/26/2022 |
| <b>R 400.8315(1)<br/>Food and<br/>equipment storage</b>                  | The thermometer in the refrigerator was broken and did not have an accurate reading on the mercury level.   | Ms. Thomason agreed to purchase a new thermometer that week.  | 05/13/2022 |


