II. Purpose of Addendum

On August 22, 2023, Jumana Jondy, licensee designee, requested to divide the Pre-K classroom into two well defined spaces.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license were modified on September 23, 2018, May 31, 2018, May 31, 2022, January 11, 2023, and September 11, 2023

The Genesee Academy Early Learning Center is located in an addition to the Genesee Academy School, which is housed in the Islamic Center of Flint. The facility is located in Swartz Creek.

The following use space was previously inspected and approved.

- The Preschool room is 26.4 ft. x 41 ft., providing a total of 1,082 square feet. This is sufficient space for the requested capacity of 25 children aged 2.5 to 10 years. If the classroom contains children aged 2-2.5 years, the capacity is 12 children.
- The Kindergarten room is 30.8 ft. x 32.8 ft., providing a total of 1,010 square feet. This space is sufficient for the requested capacity of 25 children aged 2.5 to 10 years. If the classroom contains children aged 2-2.5 years, the capacity is 12 children.

*If any classroom contains children under 2.5 years of age, the capacity of the classroom is based on 50 square feet of usable space per child. Ms. Jondy understands that the maximum group size for children aged 2-2.5 years is 12 children. Ms. Jondy understands that the maximum group size for children 2.5-3 years of age is 16 children. Ms. Jondy understands that the maximum group size for children aged 3-4 years is 30 children. Ms. Jondy understands that the maximum group size for children aged 4-10 years is 36. Ms. Jondy understands that the ratio and group size is based on the age of the youngest child.

The following space was previously inspected and approved and does not count toward the overall capacity of the facility:

- The Gymnasium is 94 ft. x 64 ft., providing a total of 3,384 square feet. This space is sufficient for 30 children aged 2.5-10 years. If the use space contains only children aged 4-10 years, the capacity is 36 children. If the

space contains children aged 2-2.5 years, the capacity is 12 children. Ms. Jondy understands that the ratio and group size is based on the age of the youngest child.

On September 11, 2023, I inspected the Pre-K room. Mrs. Jondy has purchased a room divider to separate the classroom into two use spaces. The divider has the ability to be opened for the classroom to be used as one-use space.

- The Pre-K room is 35.8 ft. x 41 ft., providing a total of 1,468 square feet. This is sufficient space for the requested capacity of 40 children aged 2.5 to 10 years. If the classroom contains children aged 2-2.5 years, the capacity is 12 children.

If the room divider is in place the following applies:

- Side 1 (closet to the classroom door) is 30 ft. x 21 ft., providing a total of 630 square feet. This space is sufficient for 18 children aged 2.5-10 years. If the space contains children aged 2.-2.5 years, the capacity is 12.
- Side 2 (closed to the kitchen) is 20 ft. x 35 ft., providing a total of 700 square feet. This space is sufficient for 20 children aged 2.5-10 years. If the space contains children aged 2-2.5 years, the capacity is 12.

The Genesee Academy Early Learning Center has a wide variety of age appropriate toys and equipment sufficient for the capacity. Environmental Health Inspections and Fire Safety Inspections were conducted at the time of original issuance. New inspections are not required. A Lead Risk assessment is not required because the facility was constructed in 2011.

Children aged 2-5 years will utilize the playground closest to the Genesee Early Learning Academy. This playground was inspected and approved on January 3, 2012. School age children who attend Genesee Academy, an approved school building, will utilize the school playground. This playground is used during the school day and parents were informed that the equipment may not comply with licensing rule 400.8170(11).

Terms:

Genesee Early Learning Academy is approved for a capacity of 90 children aged 2-10 years. The center may provide meal service including snack and lunch. During summer programming, parents will be responsible for providing meals and snacks for their children. Transportation may be available through MTA during the school year for children aged preschool and higher.

V. Recommendation

I recommend approval of the Pre-K classroom and an increase in capacity from 75 to 90 children aged 2-10 years.
