

## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### Language for Full Inspection

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

- On March 17, 2022, I provided technical assistance to Cindy Hoover, Education Coordinator regarding weather stripping on the bottom of the outside door needing replacement. On March 17, 2022, I observed one classroom rug with fraying corners that will need to be replaced soon.

The facility is in compliance with all applicable rules and statutes.

I recommend issuance of a regular license to this child care center.
