

Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

During the unannounced onsite renewal inspection, I was able to observe the structured programing, free play, outdoor play, lunch, and nap.

\*The center is approved for onsite food preparation but is no longer providing lunch to children in care. Parents provide lunch for their children.
