

| R400.8340(3) Food services and nutrition; provided by parents | There were bottles in the infant fridge which were not first name, last name, and dated. | Program director will ensure all food and beverages are labeled first name, last name, and date. | R400.8385 Poisonous or toxic materials | There were several rooms which had cleaning items in accessible to children as well as plastic bags accessible to children. | Program director will ensure that all hazardous and poisonous materials are put out of reach of children or in locked areas.
