

R 400.8182(3)(c)	In the preschool room, CCSM 4 was out of ratio with 18 children present to only her as a staff member. There was a three-year-old child present making the ratio 1:10.	Licensee will ensure a written record is completed when medication is dispensed by child care staff members to children in care and retained onsite for review.	7/28/2023
R 400.8152(2)	Program director/licensee admitted to Child A's mother a volunteer gave medication to Child A without permission., and that it was a mistake.	Licensee will ensure medication is only dispensed when written permission is given by the parent/guardian.	7/28/2023
