II. Purpose of Addendum

The licensee wishes to use Room 306 for child care use.

III. Methodology

07/08/2022 – Inspection Completed Onsite.

07/20/2022 – Modification Request Received.

IV. Description of Findings and Conclusions

The child care center is located in Goodrich United Methodist Church located on M-15 in Goodrich. The center was previously licensed at a different location under license number DC250403564.

The following rooms have been approved for child care use:

- Room 303 is 24 ft. x 18 ft., plus 20 ft. x 2 ft., plus 16 ft. x 3 ft., for a total of 520 square feet. This can accommodate up to 10 children ages 0-2 ½ years.
- Room 304 is 24 ft. x 22 ft., plus 16 ft. x 3 ft., providing a total of 576 square feet. This can accommodate up to 12 children ages 0-2 ½ years.
- Room 305 is 25 ft., 24 ft., plus 17 ft. x 9 ft., providing a total of 753 square feet. This can accommodate up to 22 children over the age of 2 ½ years.
- Room 306 is 42 ft. x 21 ft., providing a total of 882 square feet. This can accommodate up to 25 children over the age of 2 ½ years.
- The gymnasium is approximately 100 ft. x 50 ft., providing a total of 5,000 square feet. This can accommodate the center's licensed capacity.

There is a wide variety of age-appropriate toys and equipment to serve up to 50 children ages 6 weeks though 12 years.

Room 303 has its own bathroom with one toilet and one handwashing sink. There is a bathroom linking Room 304 and Room 305 with one toilet and one handwashing sink. There is an additional bathroom located off of the church lobby available for children to use. There is a total of 11 toilets, 8 handwashing sinks, and 2 urinals available. This supports the center's licensed capacity.

The area behind the church will be used for outdoor play. The area is not fenced. No water hazards were present. Direct supervision will be provided at all times.

The child care will be using renovated areas of the church. The area of the church that has Rooms 303, 304, 305, 306, and the gymnasium was built in 2006. Because the rooms were built after 1978, a lead hazard risk assessment is not required.

V. Recommendation

I recommend approval of Room 306 for child care use.
