R 400. 8134 (3)(b) Handwashing.	At the time of the inspection, Ms. Johnson did not wash an infant's hands after diapering.	Ms. Lester agreed to retrain her about this requirement.	11/03/2022 and ongoing

R 400. 8143 (3)(a) Children's records.	At the time of the inspection, 2 of the 10 children's files I reviewed had overdue immunization records. They did not have this information prior to their initial attendance.	Ms. Lester agreed to have all required immunization information within a timely manner.	11/03/2022 and ongoing
R 400. 8173 (4)(a) Equipment.	At the time of the inspection, I observed little to no outside play equipment for the children. They had a sandbox with no sand and several small balls to play with.	Ms. Lester agreed to purchase more equipment for the outdoor play area.	Within 60 days
R 400. 8185(5) Primary Care.	During the onsite inspection, primary caregiving was not being documented.	Ms. Lester agreed to start documenting this right away. They are in the process of getting an online app called Brightwheel that will document this.	11/03/2022 and ongoing


