

## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

- On September 15, 2022, I provided technical assistance to Jeff Guza, Program Director/Licensee Designee regarding the following:

- Maintenance of the child care background check system and the definition of a child care staff member, including staff providing special services (ie speech, OT, PT, Social Work).
- Adding the requirement of a PSOR clearance to volunteer application/screening page.
- Ensuring that the section on the child emergency document includes a response in the allergies, special needs section.
- Adding a statement in the emergency plans regarding children with special needs or chronic medical conditions.
- I provided Mr. Guza with a link to the center orientation training calendar.

#### IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
