II. Purpose of Addendum

On July 28, 2022, Joseph Candela, licensee designee, requested the addition of Classroom 2 to the list of child approved use spaces.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license were modified on August 30, 2022.

Ugly Community Schools Pre-School is in a single-story building in Ugly.

The following spaces were previously inspected and approved:

- Classroom 3 is 23 ft. x 33 ft., providing a total of 759 square feet. This allows for a capacity of 22 children aged 3-12 years.
- Classroom 4 is 25 ft. x 33 ft., providing a total of 825 square feet. This allows for a capacity of 24 children aged 3-12 years.

The following space is approved and does not count toward the building capacity:

- Classroom 1 is 23 ft. x 33 ft., providing a total of 759 square feet. This allows for a capacity of 22 children aged 3-12 years.

On August 29, 2022, inspected Classroom 2.

- Classroom 2 is 23 ft. x 33 ft., providing a total of 759 square feet. This allows for a capacity of 22 children aged 3-12 years.

The facility has seven toilets, five sinks and two urinals. This is sufficient for the requested capacity of 68 children aged 3-12 years.

The facility has a wide variety of age appropriate equipment and materials. The facility has ample equipment to support the building capacity.

Outdoor play will occur on the side of the building. The area is fenced and does not contain any water hazards. Outdoor equipment will be supplied by the facility and the area does not contain any commercial playground equipment. Direct supervision will be provided during outdoor play.

The facility received an "A" rated Environmental Health inspection on February 10, 2021. The facility received an "A" rated Fire Safety Inspection on November 20, 2020. The facility had a lead hazard risk assessment on August 20, 2018, no lead risk hazards were identified. The building was determined safe for child care usage. New inspections are not required at this time.

Terms:

Transportation and food service will be available through Ugly Community Schools. Breakfast, lunch, and afternoon snack will be provided. Swimming will not be provided.

V. Recommendation

I recommend approval of Classroom 1 and an increase in capacity from 46 to 68 children aged 3-12 years.
