A limited number of cups were poured and when they were gone the children at the end of the line were not offered any. There were not enough brownies set out for all the children.	The program director will ensure that snacks meet USDA guidelines. Prior to getting snacks ready, staff will check in with the program director for the number of children present that day. The program director will make sure that enough snacks are provided for all children. The snack menu will be shared with the licensee designee weekly. R 400.8131(11)	Four child care staff member files did not have verification of 16 hours of professional development in the file or on MiRegistry.	Verification of professional development will be brought to the site and put in staff files. Moving forward, verification of professional development will be updated as trainings are done by all staff monthly. Licensee designee will monitor quarterly to ensure verification is present in each staff file.	10/04/2022
R 400.8161(7)	There was no written log indicating the time and date of fire and tornado drills at the center. Ms. Bramble said they perform the drills, but they have not been logged.	Fire/tornado log will be printed and posted on the cabinet with other required postings. The program director will record practice drills that have already been done, along with all future drills. Licensee designee will monitor quarterly to ensure the drills are documented.	10/04/2022

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.
