400.8179(10)(a) Program.	Child A used her personal media device to take inappropriate pictures of herself and Child B and Child C, that included private body parts. This is not an appropriate use of media.	Ms. Bobbitt and Mr. Weaver Sr. have developed a new center policy that inform parents that there is a no electronic device policy/rule that no longer permit the use of electronic devices. Ms. Bobbitt and Mr. Weaver Sr. will enforce this policy and parents are required to read and agree to this new policy. This policy has been implemented as of 04/03/2022. Compliance will be maintained through the use of the no electronic device policy in the center's handbook.	06/15/2022
