**III. DESCRIPTION OF FINDINGS & CONCLUSIONS**

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the onsite inspection observed arrival, large group, hand washing, toileting, snack, music, art, and outside time. Interactions between child care staff members and children were positive and developmentally appropriate.

The facility is in compliance with all applicable rules and statutes.

Technical assistance was given on emergency cards, crisis management plan and hand washing.

#### IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
