As a result of the renewal inspection(s) on 2/26/2024, licensing consultant Michael Skonieczny did not find any rule or law violations. A regular license will be issued.

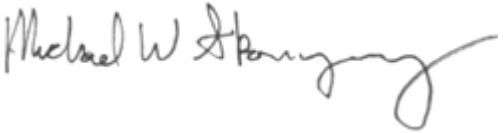
