III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

I provided a rule review regarding:

- The center does not currently use volunteers. If volunteers are used in the future, I reviewed the new screening requirements including PSOR clearances for all supervised volunteers.
- Written emergency plans need to be specific to each type of required emergency, including incidents. Be sure to include individual special accommodations if needed.
- Signed parent acknowledgement of receipt of handbook. I provided an example form.
- The center is updating their parent handbook. The school age program will now be included in one center handbook.
- Health and Safety training updates through MI Registry.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
