

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the inspection, the center was found to be in compliance with all applicable rules and statutes except for the following violations:

R 400.8161 Emergency procedures.

**(2) The written procedures must include all of the following:
 (f) A plan for how each child with special needs will
 be accommodated during each type of emergency.**

R 400.8161 Emergency procedures.

**(2) The written procedures must include all of the following:
 (h) A plan for how children with chronic medical
 conditions will be accommodated during each type of
 emergency.**

The center did not have written plans for how children with special needs and children with chronic medical conditions will be accommodated during each type of emergency.

A corrective action plan was requested and approved on 02/19/2021. It is expected that the corrective action plan be implemented within the specified time frames as outlined in the approved plan. A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
