

**III. DESCRIPTION OF FINDINGS & CONCLUSIONS**



Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

During my onsite inspection, I observed free play, lunch time and nap time. Interactions between child care staff members and child care children were positive. A rule review was provided in regards to maintenance of premises, crisis management plans, hand washing and required postings.

I recommend issuance of a regular license to this child care center.
