

**III. DESCRIPTION OF FINDINGS & CONCLUSIONS**


This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

During my onsite inspection I observed free play, large group and lunch time. Interactions between child care staff members and child care children were positive. A rule review was provided in regards to verifications of training, emergency numbers, posted emergency plans, soft objects in the infant room and supervision.

#### IV. RECOMMENDATION

I recommend issuance of a regular child care license to this center.
