### Findings of the Inspection

The renewal inspection involved a review of all applicable child care center [administrative rules](#) and [statutes](#). Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During my on-site inspection I observed dinner preparation, arrival, dinner, activity time, free time, and early dismissal. Child care staff members interacted with children in a positive and friendly manner. Staff were providing appropriate care and supervision during programming, transitions, and

activities. Activities planned were developmentally appropriate and engaging. Center, staff, and child records were organized, complete, and made readily available.

As a result of the renewal inspection on 2/13/2024, licensing consultant Jessica Miranda-Bevier did not find any rule or law violations. A regular license will be issued.
