II. Purpose of Addendum

On 03/22/2021 I received a modification request form from licensee designee and program director, Kassandra Gutierrez requesting the addition of food service as a program component.

III. Methodology

IV. Description of Findings and Conclusions

The terms of this license have been modified on 03/15/2017, 08/24/2018, 09/02/2020, and 03/22/2021.

Living Stones Academy Preschool is housed in the Living Stones Academy school building which includes grades Preschool through Sixth.

The following rooms are approved for child use space:

- Preschool (room 107) is 35 ft X 29 ft. providing a total of 1,015 square feet. This accommodates 29 preschool aged children. The requested capacity for this room is 24 children.
- Library (room 103) is an irregularly shaped room measuring approximately 39 ft. X 23 ft. and 4.5 ft. X 14 ft. providing a total of 960 square feet. This accommodates 27 preschool aged children.
- Music Room (room 112) is approximately 29 ft. X 28 ft. providing a total of 812 square feet. This accommodates 23 preschool aged children.
- Gymnasium is approximately 56 ft. X 36 ft. providing a total of 2,184 square feet. This accommodates 62 preschool aged children.

The total space is sufficient for a total capacity of 24 preschool aged children.

There are seven sinks and 13 toilets and four urinals accessible to preschool children. This supports the center's capacity.

Room 107 is furnished with a variety of developmentally appropriate equipment.

An "A" rated environmental health inspection was completed on 07/31/2014. A Certification of School Building Fire Safety Provisions (BCAL-5043) was signed by the head of school on 01/24/2019. A Lead Hazard Risk Assessment was completed on 09/16/2014. The assessment documents that there are no lead hazards present in the facility.

The playground was inspected on 09/27/2016. All equipment complied with playground requirements at the time of the inspection.

Terms:

The center is approved for a total capacity of 24 children aged three to five.

The center offers both full-time and part-time programming.

Snacks and lunches are provided by parents of enrolled children. Children do have the option to order lunches from the school. The kitchen is licensed and food is prepared on-site.

The program does not offer swimming or transportation.

V. Recommendation

I recommend approval of the addition of food service as a program component.
