II. Purpose of Addendum

On May 28, 2021 Licensee designee Cali Lipscomb submitted a modification request to change the age range for previously approved classrooms 504 and 505.

III. Methodology

03/29/2021- On-site inspection completed.

05/28/2021- Modification request received.

06/03/2021- Terms updated.

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 04/12/2021 and 06/03/2021.

On 05/28/2021 Licensee designee Cali Lipscomb submitted a modification request to change the age range for previously approved classrooms 504 and 505. Classrooms 504 and 505 were previously measured and approved for school age children but will now include a capacity for toddler and preschool age children.

An "A" rated environmental health inspection was completed on 02/19/2021.

A lead risk assessment was completed on 05/27/2021 and no hazards were identified.

On March 29, 2021 I completed an onsite visit at the facility and measured and approved rooms 504 and 505. Ms. Lipscomb identified the following rooms would be utilized for toddlers and preschool age children:

Room 504: Measures 13' x 2' for a square footage of 26 and 36' x 24' for a square footage of 864. Total square footage for the room is 890 square feet. This allows for a capacity of 18 children under the age of 2.5 and 25 over the age of 2.5. Maximum group size per age group will be adhered to. There is one bathroom with one toilet and one sink along with an extra sink in this classroom.

Room 505: Measures 13' x 2' for a square footage of 26 and 37' x 24' for a square footage 888. Total square footage for the room is 914 square feet. This allows for a capacity of 18 children under the age of 2.5 and 26 children over the age of 2.5. Maximum group size per age group will be adhered to. There is one bathroom with one toilet and one sink along with an extra sink in this classroom.

Previously approved space included:

Room 401: Measures 9' x 2' for a square footage of 18, 29' x 15' for a square footage of 435, 6' x 3' for a square footage of 18, 7' x 3' for a square footage of 21, 14' x 29' for a square footage of 406, and 3' x 27' for a square footage of 81. Total square footage of the room is 979 square feet. This allows for a capacity of 28 school age children.

Room 402: Measures 9' x 2' for a square footage of 18, 20' x 3' for a square footage of 60, and 35' x 25' for a square footage of 875. Total square footage of the room is 953 square feet. This allows for a capacity of 19 children under the age of 2.5 and 27 child over the age of 2.5. Maximum group size per age group will be adhered to.

Room 403: Measures 20' x 3' for a square footage of 60 and 34' x 25' for a square footage of 850. Total square footage of the room is 910 square feet. This allows for a capacity of 18 children under the age of 2.5 and 26 children over the age of 2.5. Maximum group size per age group will be adhered to.

Room 404: Measures 4' x 11' for a square footage of 44, 16' x 8' for a square footage of 128, 15' x 26' for a square footage of 390, 20' x 1' for a square footage of 20, 28' x 20' for a square footage of 560, and 7' x 2' for a square footage of 14. Total square footage of the room is 1,156 square feet. This allows for a capacity of 23 children under the age of 2.5 and 33 children over the age of 2.5. Maximum group size per age group will be adhered to. There are five sinks in this classroom.

Room 405: Measures 9' x 2' for a square footage of 18, 45' x 28' for a square footage of 1,260. Total square footage of the room is 1,278 square feet. This allows for 26 children under the age of 2.5 and 37 children over the age of 2.5. Maximum group size per age group will be adhered to.

Room 406: Measures 18' x 2' for a square footage of 36, 17' x 2' for a square footage of 34, 44' x 36' for a square footage of 1,584. Total square footage of the room is 1,654 square feet. This allows for 47 school age children. There is one sink in this classroom.

Room 407: Measures 4' x 2' for a square footage of 8, 15' x 5' for a square footage of 75, 7' x 2' for a square footage of 14, 27' x 34' for a square footage of 918. There is a shelving unit that measures 13' x 2' for a square footage of 26 that will not be used as child care use space. Total square footage for the room minus the shelving unit is 989. This allows for 28 school age children. There are five sinks in this classroom.

The gymnasium and cafeteria are approved for use space.

The facility has 26 sinks, 15 toilets, and one urinal located in classrooms and nearby hallways. This is more than adequate to support the total requested capacity of 202 children.

V. Recommendation

I recommend the use of classrooms 504 and 505 for toddler and preschool age children.
