

Professional development requirements.

(5) Within 90 days of being hired, or the first day as an unsupervised volunteer, all child care staff members and unsupervised volunteers who work directly with children shall complete the following trainings, which may count toward annual professional development hours and are available at MiRegistry:

- (a) Administration of medication.**
- (b) Prevention of and response to emergencies due to food and allergic reactions.**
- (c) Building and physical premises safety.**
- (d) Emergency preparedness and response planning.**
- (e) Handling and storage of hazardous materials and appropriate disposal of bio-contaminants.**
- (f) Precautions in transporting children, if applicable.**
- (g) Child development.**

At the time of the onsite inspection, program director Kimberly Diefenbach and child care staff member Samantha Hueter had not completed the required 8 hours of Health & Safety training. This training can be found at www.miregistry.com and a brochure regarding this training is enclosed.

Emergency procedures.

(2) The written procedures must include all of the following:

- (a) A plan for evacuation.**
- (b) A plan for safely moving children to a relocation site.**
- (c) A plan for shelter-in-place.**
- (d) A plan for lockdown.**
- (e) A plan for contacting parents and reuniting families.**
- (f) A plan for how each child with special needs will be accommodated during each type of emergency.**
- (g) A plan for how infants and toddlers will be accommodated during each type of emergency.**
- (h) A plan for how children with chronic medical conditions will be accommodated during each type of emergency.**


Written emergency plans regarding the above scenarios were not available at the time of the onsite inspection.

*Technical assistance and consultation were given regarding licensing rule R 400.8112(5) Comprehensive background check; fingerprinting. (The Consent & Disclosure Statement completed by each child care staff member must be kept on file or readily accessible.

A corrective action plan was requested and approved on 05/10/2021. It is expected that the corrective action plan be implemented within the specified time frames as outlined in the approved plan. A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
