Approved Child Use Space:

Adrian Head Start at Hudson is located in a portable classroom on the premises of Lincoln Elementary School in Hudson. Lincoln Elementary is an active school building serving grades kindergarten through fifth grade. The center utilizes the entire portable modular classroom as approved child use space. The center offers fulltime preschool programming Monday through Friday from 8:00 am until 3:00 pm through the school year. The center provides breakfast, lunch and snacks for the children that are prepared in a centralized kitchen operated by Hudson School District. Transportation services are provided by the parents and Hudson School District.

During my onsite inspection on 5/25/23, I observed the children during small and large group activities, outdoor play and lunch. I also observed a child being picked up by their parent. The portable classroom was equipped with an adequate amount of age-appropriate play and learning equipment conducive to a preschool setting. The center provides the children with daily various activities that include circle time, name and letter recognition, counting activities, music and reading instruction, and various arts and craft activities. Child care staff member interactions with children was positive and nurturing.
