On August 9, 2022, licensee designee, Ms. Cynthia McClafferty, submitted a modification form to change the age of Classroom 230 for preschoolers. This room will be used as the second Preschool Classroom.

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 09/12/2011, 10/12/2012, 09/23/2013, 10/28/2015, 10/25/2017, 05/20/2019, 10/05/2020, 03/23/2022, and 09/06/2022.

- **September 6, 2022** – On August 9, 2022, licensee designee, Ms. Cynthia McClafferty, submitted a modification form to change the age of Classroom 230 for preschoolers. This room will be used as the second Preschool Classroom.

- **March 23, 2022** – On March 14, 2022, licensee designee, Mrs. Cynthia McClafferty, submitted a modification request form to increase the capacity from 100 to 280 to accommodate the summer program. Please note: The Gymnasium was measured and added to the licensed capacity. The Cafeteria and Gymnasium were measured in well-defined spaces to maintain compliance with the maximum group size.

- **October 5, 2020**- On August 14, 2020, licensee designee, Mrs. Cynthia McClafferty, submitted a modification request form to add a room next to the Main Office as approved space for the children in care. The room will be used as an isolation/sick room.

- **May 20, 2019** – On April 29, 2019 – A modification request form was submitted to increase the capacity from 96 to 100, add a summer program and add Classroom #210, Classroom #200, Classroom #250, Classroom #370 Art Room, Classroom #380 Music Room and Media Center as approved space for child care use.
- **October 17, 2017** – A modification request form was submitted to add preschool age to the before and after school program.
- **October 28, 2015** – During the on-site renewal inspection on 10/20/2015 the preschool program was using previously approved classroom 220 instead of room 240, which was being used during the 2013 renewal inspection. Classroom #220, Gym/Cafeteria, Classroom #240 and Classroom #230 are approved for child care use.
- **September 23, 2013** – On July 11, 2013, a modification request form was submitted to add Classroom #230. Country Elementary School offers a preschool program and before and after school care for children ages 3 years through 12 years old. The preschool classes are held on Tuesday and Thursday mornings for 3 years old children and Monday, Wednesday and Friday mornings for 4 years old children. The preschool hours for both age groups are 9:00 AM to 12:00 PM.
- **October 12, 2012** – The licensee designee, Mr. Tedd Bradley, requested to add Room #220 for child care use.
- **September 12, 2011** – On April 20, 2010, the licensee designee submitted a modification request form to: (1) Add Room #240, (2) Change the age range to include 3 years through 4 years old, (3) Addition of a preschool component and (4) Increase the capacity from 90 to 96.

The preschool program is located in Country Elementary School. The program offers preschool during the school year, Monday through Friday. It also offers a summer program for children ages 3 years through 12 years old. The summer program operates Monday through Friday from 6:30 A.M. to 6:00 P.M. from June through August.

The summer program offers swimming and transportation for the school-age children only. The children will use the L.E.T.S. public transportation. The preschool age children will not be swimming nor will they be using the transportation. The preschoolers will not participate with the school-age children's activities.

All snacks and lunches are provided by parents. Parents will have the option of purchasing a slice of pizza at snack time twice a week from Hungry Howie's Pizza.

The following rooms are approved for child care use:

Classroom #200 is measured at 21.916 x 17.5 plus 9.583 x 17.25 for a total of 548.84 sq. ft. At 35 square feet per child, the capacity of this room is 16 children. The teacher's desk area was excluded from the square footage. This room is used for the summer program.

Classroom #210 is measured at 24.75 x 12.75 plus 7.666 x 20.666 for a total of 473.99 sq. ft. At 35 square feet per child, the capacity of this room is 14 children. There is a room located inside Classroom #210; this room is not approved for child care use. This room is used for the summer program.

Classroom# 220 is currently being used as the Preschool Classroom. It was previously measured 30.5 x 30 for a total of 915 sq. ft. At 35 square feet per children, the capacity of this room is 26 children. This room is also used for the summer program.

Classroom# 230 will be used as the second Preschool Classroom. It was previously measured 29 x 30 for a total of 870 sq. ft. At 35 square feet per child, the capacity of this room is 25 children. This room is also used for the summer program.

Classroom# 240 was previously measured 29 x 28 for a total of 812 sq. ft. At 35 square feet per child, the capacity of this room is 23 children. This room is used for the summer program.

Classroom# 250 is measured at 18.833 x 29.25 plus 6.333 x 20.583 for a total of 681.22 sq. ft. At 35 square feet per child, the capacity of this room is 20 children. This room is used for the summer program.

Classroom# 370 (Art Room) is measured at 25.416 x 24.333 plus 9 x 12 for a total of 726.45 sq. ft. At 35 square feet per child, the capacity of this room is 21 children. The capacity of this room is excluded from the center's overall capacity.

Classroom# 380 (Music Room) is measured at 25.5 x 28.0 plus 8.25 x 22.583 for a total of 900.31.45 sq. ft. At 35 square feet per child, the capacity of this room is 26 children. The capacity of this room is excluded from the center's overall capacity.

Media is measured at 20.666 x 18.083 plus 46.5 x 29.0 plus 38.33 x 19.50 for a total of 2469.69 sq. ft. At 35 square feet per child, the capacity of this room is 71 children. The capacity of this room is excluded from the center's overall capacity.

Cafeteria was measured in three well-defined spaces (tape):

- Stage is measured approximately 5.0 x 41.0 plus 2.0 x 35.0 plus 3.0 x 25.0 plus 3.0 x 17.0 for a total of 401.0 sq. ft. At 35 square feet per child, the capacity of this space is 12 children.
- Left side of the Cafeteria is measured at 34.0 x 38.0 for a total of 1292 sq. ft. At 35 square feet per child, the capacity of this space is 36 children.
- Right side of the Cafeteria is measured at 34.0 x 38.0 for a total of 1292 sq. ft. At 35 square feet per child, the capacity of this space is 36 children.

Gymnasium was measured in two well-defined spaces (blue tape):

- Left side of the Gymnasium is measured at 34.0 x 45.0 for a total of 1530 sq. ft. At 35 square feet per child, the capacity of this space is 43 children. The licensee designee has requested to reduce the capacity to 36. Therefore, the capacity of this space is 36 children.
- Right side of the Gymnasium is measured at 34.0 x 45.0 for a total of 1530 sq. ft. At 35 square feet per child, the capacity of this room is 43 children. The licensee designee has requested to reduce the capacity to 36. Therefore, the capacity of this space is 36 children.

Please note: The Cafeteria and Gymnasium are approved for children ages 3 years through 12 years old.

- Children ages 3 years of age until 4 years of age has a ratio of 1 child care staff member to 10 children with a group size of 30.
- Children ages 4 years of age until school-age has a ratio of 1 child care staff member to 12 children with a group size of 36.
- School-ager has a ratio of 1 child care staff member to 18 children with a group size of 36.
- If there are children of mixed ages in the same room or well-defined space, then the ratio and group size shall be determined by the age of the youngest child, unless each group of children is clearly separated and the appropriate child care staff member-to-child ratios and group sizes, if applicable, for each age group are maintained.

Isolation/Sick Room is located next to the Main Office. The small office was measured at 10.083 x 9.166 plus 6.33 x 4.666 equals 121.96 sq. ft. At 35 square feet per child, the capacity of this room is 4 children. The capacity of this room is excluded from the center's overall capacity.

The capacity of the center at any one time cannot exceed 280 children.

There is a total of 22 toilets, 33 hand washing sinks and 6 urinals.

The building was built in 1980 and does not require a lead hazard risk assessment.

V. Recommendation

I recommend approving Classroom 230 as a second Preschool Classroom.
