## II. Purpose of Addendum

On July 27, 2022, licensee designee, Ms. Sandra Nettleingham, submitted a modification request form to:

- Add Classroom 103, Classroom 102 Art Room, Classroom 108 Music Room, and
- Increase the capacity from 20 to 40.

Please note: The 3's and 4's will be in Classroom 104. The 3's will attend on Tuesday and Thursday from 8:30 A.M. – 11:00 A.M. The 4's will attend on Monday, Wednesday, and Friday from 8:30 A.M.- 11:30 A.M.

The Young 5's (Beginnergarten) will be in Classroom 103. The Young 5's will attend Monday through Friday from 8:30 A.M. - 11:30 A.M.

The child care program will offer child care from 11:00/11:30 A.M. – 3:30 P.M. Classroom 104 for 3's, 4's and 5's.

The child care program will offer before and after school care for children ages 3 years through 12 years old, Monday through Friday from 7:00 A.M. – 8:30 A.M., and from 3:30 P.M. – 6:00 P.M. The before and after school care will be in Classroom 104.

## IV. Description of Findings and Conclusions

The terms of the original license have been modified on March 3, 2017, April 26, 2017, February 20, 2018, March 7, 2019, August 13, 2020, and August 8, 2022.

- March 3, 2017 - The chapel was approved space for child care use, and the hours of operation and classroom numbers were updated. The current approved room number is 202-204. The room number was re-assigned; the updated room number is 104. The hours of operation have changed to the following:

- The 4's Class attends on Monday, Wednesday, and Friday from 8:30 A.M. – 11:30 A.M.
  - The 3's Class attends on Tuesday and Thursday from 8:30 A.M. – 11:00 A.M.
  - The Beginner garden (older 4's and young 5's) attend Monday through Thursday from 12:30 P.M. – 3:30 P.M.
- April 4, 2017- On April 4, 2017, Ms. Nettleingham, submitted a modification request form to add a school-age before and after school child care component, increase age range, and approve Classroom #107 and Classroom #102 as child care space. The school-age before and after school program will operate Monday through Friday from 7:30 A.M. – 8:00 A.M. and from 3:45 P.M. – 6:00 P.M. The program will accept children ages 5 years through 12 years old.
  - January 31, 2018- On January 31, 2018, Ms. Nettleingham, submitted a modification request form to add Classroom #106 as approved space for the children in care.
  - February 28, 2019- On February 28, 2019, Ms. Nettleingham, submitted a modification request form to remove Classroom #106 as approved space for the children in care.
  - August 13, 2020 – On August 13, 2020, licensee designee, Ms. Sandra Nettleingham, submitted a modification request form to add the Assistant Principal's Office to be used as a sick room for the children in care.
  - August 8, 2022 – On July 27, 2022, licensee designee, Ms. Sandra Nettleingham, submitted a modification request form to: Add Classroom 103, Classroom 102 Art Room, Classroom 108 Music Room, and increase the capacity from 20 to 40.
    - Please note: The 3's and 4's will be in Classroom 104. The 3's will attend on Tuesday and Thursday from 8:30 A.M. – 11:00 A.M. The 4's will attend on Monday, Wednesday, and Friday from 8:30 A.M.- 11:30 A.M.
    - The Young 5's (Beginner garden) will be in Classroom 103. The Young 5's will attend Monday through Friday from 8:30 A.M. - 11:30 A.M.
    - The child care program will offer child care from 11:00/11:30 A.M. – 3:30 P.M. Classroom 104 for 3's, 4's and 5's.
    - The child care program will offer before and after school care for children ages 3 years through 12 years old, Monday through Friday

from 7:00 A.M. – 8:30 A.M., and from 3:30 P.M. – 6:00 P.M. The before and after school care will be in Classroom 104.

The child care center is located in a building that is a church and school building combined. The area of the building to be used for child care is separated by approved fire safety doors and is located in the southwest portion of the building.

**The approved space is as follows:**

- **Sick/ Isolation Room (Assistant Principal's Office)** measured approximately at 6'5" x 12'0" plus 8'5" x 2'4" = 97 sq. ft. divided by 35 sq. feet per child equals 3 children. The capacity of this classroom is 3 children. *The square footage from this room is excluded from the total capacity.*
- **Classroom 102 (Art Room; 3 years through 12 years old)** measured 49'6" x 25'8" = 1271 sq. feet divided by 35 sq. feet per child equals 36 children. The capacity of this classroom is 36 children. However, it has been requested to maintain the capacity at 20 children. *The square footage from this room is excluded from the total capacity.*
- **Classroom 103** (3 years through 12 years old) measured 38 x 19.833 plus 6 x 12 plus 6 x 11 equals 891.70 sq. feet. At 35 sq. feet per child, the capacity of this classroom is 26 children. The capacity of this classroom is 26 children. However, it has been requested to maintain the capacity at 20 children.
- **Classroom 104** (formerly Classroom 202-204; preschool classroom, approved for children ages 3 years old through 12 years old) measured 38 x 19.833 plus 6 x 12 plus 6 x 11 equals 891.70 sq. feet. At 35 sq. feet per child, the capacity of this classroom is 26 children. The capacity of this classroom is 26 children. However, it has been requested to maintain the capacity at 20 children.
- **Classroom 107** (3 years through 12 years old) measured 21'0" x 28'11" = 607.24 sq. feet plus 4'8" x 22'11" = 106.93 sq. feet for a total of 714.17 sq. feet divided by 35 sq. feet per child equals 20 children. The capacity of this classroom is 20 children. *The square footage from this room is excluded from the total capacity.*
- **Classroom 108 (Music Room; 3 years through 12 years old)** measured 22.67 x 6.0 plus 26.25 x 23.58 equals 755.0 sq. feet. At 35 sq. feet per child, the capacity of this room is equals 22 children. However, it has been requested to maintain the capacity at 20 children. *The square footage from this room is excluded from the total capacity.*

- **Gymnasium** is located at the main entrance of the school building. The gym is divided in the middle to provide two separate spaces to accommodate the group size requirements. Each side is measured at 49.083 x 67.0 equals 3289.0 sq. feet. At 35 sq. ft. per child, the capacity for each side is 94 children ages 3 years old through 12 years old. *The square footage of this room is not included in the total capacity.*

**Please note:**

- Preschoolers, 30 months of age until 3 years of age, has a ratio of 1 child care staff member to 8 children, with a maximum group size of 16.
  - Preschoolers, 3 years of age until 4 years of age, has a ratio of 1 child care staff member to 10 children, with a maximum group size of 30.
  - Preschoolers, 4 years until school age, has a ratio of 1 child care staff member to 12 children, with a maximum group size of 36.
  - School-agers has a ratio of 1 child care staff member to 18 children, with a maximum group size of 36.
  - If there are children of mixed ages in the same room or well- defined space, then the ratio and group size are determined by the age of the youngest child, unless each group of children is clearly separated and the appropriate child care staff member to child ratios and group sizes, if applicable.
- **The Chapel-** (Chapel A, B and C) The Chapel is located down the hallway from Classroom 104. The square footage in this room can accommodate and exceeds the license capacity of 40. *The square footage from this room is excluded from the total capacity.*

Although the total capacity exceeds the licensed capacity, Ms. Nettleingham has requested the capacity be at 40. Therefore, **the total capacity in the center at any one time cannot exceed 40 children.**

There are 13 toilets, 5 urinals, and 14 sinks available for child care use. There are additional toilets and hand washing sinks located throughout the school building:

There are bathrooms located across from Classroom 102 by the Chapel:

- In the girls' bathroom, there are 2 handwashing sinks and 4 toilets.
- In the boys' bathroom, there are 2 hand washing sinks, 3 urinals and 1 toilet.

There are bathroom located across from the Gymnasium:

- In the girls' bathroom, there are 2 handwashing sinks and 4 toilets.
- In the boys' bathroom, there are 2 hand washing sinks, 2 urinals and 2 toilet.

In Classroom 103, there is 2 handwashing sinks. There is also a bathroom with 1 handwashing sink and 1 toilet.

In Classroom 104, there is 2 handwashing sinks. There is also a bathroom with 1 handwashing sink and 1 toilet.

The child care center does not provide any meals. Parents are responsible for providing the lunches and snacks. There is no transportation. There is no swimming component.

The child care wing was constructed circa 2002, and therefore does not require a lead inspection.

On September 4, 2012, the playground was inspected and approved by Eric Sheffer, Certified Playground Safety Inspector.

## V. Recommendation

I recommend adding Classroom 103, Classroom 102 Art Room, Classroom 108 Music Room, and increasing the capacity from 20 to 40.

I also recommend changing the child care program to the following:

- The 3's and 4's will be in Classroom 104. The 3's will attend on Tuesday and Thursday from 8:30 A.M. – 11:00 A.M. The 4's will attend on Monday, Wednesday, and Friday from 8:30 A.M.- 11:30 A.M.
- The Young 5's (Beginnergarten) will be in Classroom 103. The Young 5's will attend Monday through Friday from 8:30 A.M. - 11:30 A.M.
- The child care program will offer child care from 11:00/11:30 A.M. – 3:30 P.M. Classroom 104 for 3's, 4's and 5's.
- The child care program will offer before and after school care for children ages 3 years through 12 years old, Monday through Friday from 7:00 A.M. – 8:30 A.M., and from 3:30 P.M. – 6:00 P.M. The before and after school care will be in Classroom 104.
