This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 12/10/2021. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8119 Site supervisor; qualifications; responsibilities.

- (2) Site supervisors shall meet all of the following requirements:
(d) Have completed 15 clock hours, 1 semester hour, or 1.5 CEUs of documented school-age training.

The site supervisor (D.J.) does not have 15 clock hours, 1 semester hour, or 1.5 CEUs of documented school-age training.

The program director (J.G.) resigned at the beginning of the school year in August 2021.

Professional development requirements.

(3) Before caring for children, all child care staff members and unsupervised volunteers who work directly with children shall be trained on prevention of shaken baby syndrome, abusive head trauma and child maltreatment, and recognition and reporting of child abuse and neglect.

Child care staff member (D.W.) has not completed training on the prevention of shaken baby syndrome, abusive head trauma and child maltreatment, and recognition and reporting of child abuse and neglect.

Professional development requirements.

(4) Before unsupervised contact with children, all child care staff members who work directly with children shall complete prevention and control of infectious disease training, including immunizations.

Child care staff member (D.W.) has not completed the prevention and control of infectious disease training, including immunizations.

On December 10, 2021, you gave us an acceptable written corrective action plan.
