III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

The facility is in compliance with all applicable rules and statutes.

Technical Assistance and Consultation were provided for the following:

- *R 400.8161 (5) Emergency Procedures.* A fire drill program, consisting of at least 1 fire drill quarterly, must be established and implemented. Quarterly means once per three month period.
- *R 400.8110 (3) Applicant; licensee; licensee designee; requirements.* Add PSOR verbiage.
- *R 400.8110 (6) Applicant; licensee; licensee designee; requirements.* The licensee or licensee designee shall maintain accurate daily records detailing arrival times and departure times for each child care staff member, child care aide, and volunteer.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
