IV. Description of Findings and Conclusions

The terms of the original license have been modified on 05/24/2023, 07/07/2022 and 08/11/2017.

A. Description of Facility

This child care center is a preschool located in the Mackinac Island Public School, located on Mackinac Island.

Approved space (room numbers, sizes, capacity and ages of children for which each room/well-defined space is approved, etc.):

The preschool room is number 140 on the main floor of the school next to the kitchen. The classroom is 19 feet x 31 feet and 17 feet x 7 feet for a total of 708 square feet. This will more than accommodate the requested capacity of 15 children, age 2 years 6 months through 5 years 11 months.

Equipment:

The equipment and supplies on site are developmentally appropriate and adequate for the requested capacity.

Number of sinks and toilets:

There is a bathroom in the classroom with one toilet. The hand-washing sink is adjacent to the bathroom inside the classroom area.

Outdoor play area - location, fenced or not, water hazards:

The outdoor play area is located on the school playground with use of only the equipment approved for preschool children. It is unfenced and there are no water hazards on site.

Documentation if a lead assessment was required and the results:

A lead assessment was completed in August 2013 and indicated that zero lead hazards were identified in the building.

Documentation of playground safety:

A playground inspection is on file for the approved preschool equipment.

B. Program Description

Ages of children served:

The program is licensed for children aged 2 years six months through 5 years 11 months.

Proposed days and hours of operation:

The center will operate Monday through Friday from 08:20am to 3:00pm. The preschool will follow the Mackinac Public School calendar and days off September through May. The summer program will run June through August.

Full or part time (AM or PM sessions or both):

This is a full time program.


Other program components - transportation, swimming, food service:

The food service is provided by the school lunch program. The children will be able to eat in the cafeteria or classroom. Transportation is provided by the parents.
