This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 05/05/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8350 Toilets; hand washing sinks.

(5) Hand washing sinks must have warm running water not to exceed 120 degrees Fahrenheit.

During the onsite inspection the two hand washing sinks in room #6 warm running water exceeded 120 degrees Fahrenheit. The first sink read at 131 degrees Fahrenheit, and the second sink read at 129 degrees Fahrenheit.

Due to the violations, you must send us a corrective action plan by 05/20/2022. You can use our [corrective action plan](#) form or create your own.

If you need help writing the corrective action plan, please contact me. If you do not send a corrective action plan, you may face disciplinary action. The corrective action plan must include the following:

- How compliance with each rule will be achieved.
- Who is directly responsible for implementing the corrective action for each violation.
- Specific time frames for each violation as to when the correction will be completed or implemented.
- How continuing compliance will be maintained once compliance is achieved.
- The signature of the responsible party and a date.

Upon receipt of an acceptable corrective action plan, there will be no change to your license status.
