<b>R 400.8182(3)(a)</b>	During the onsite inspection, the toddler room had a total of five toddlers with only one child care staff member in the classroom.	Scheduling will be maintained for the rooms to have the appropriate teacher to child ratio.	Immediately
<b>R 400.8182(7)</b>	During the onsite inspection on May 20, 2022, Program Director Ms. Valentine was caring for children of mixed ages in the preschool room that included seven preschoolers and four toddlers. In addition, Child A's Mother witnessed upon pick up one child care staff member caring for a total of eight children with the youngest being about four months old to the oldest being four years old.	Children of mixed ages will not be cared for in a room together. If this does happen for an emergency reasons, there will be appropriate staff to maintain the ratio to group size rule.	Immediately
<b>R 400.8330(10)</b>	During the onsite inspection on March 28, 2022, the center did not have a menu available or posted for the parents to review.	Menus will be placed at the entrance foyer on the parent's bulletin board.	Immediately
<b>R 400.8110(6)</b>	During the onsite inspection on May 20, 2022, Program Director Ms. Valentine was unable to provide the required daily arrival and departure times for attendance documentation for child care staff member Raney Yousif and herself.	All staff members, child care aides, and volunteers will have documentation regarding arrival and departure times.	Immediately
<b>R 400.8176(13)</b>	During the onsite inspection on May 20, 2022, I observed one infant that was in a crib with a small blanket.	There shall not be any soft objects, bumper pads, stuffed toys, blankets, quilts, comforters, and other objects that could smother a child within reach of crib or resting with a sleeping infant.	Immediately
