There is now a mandatory head count put in place before and after all transitions and shift changes. In addition, door alarms have been installed on each door that will alert all staff if door opens. R 400.8131(2)	Child Care Staff Member 2, Child Care Staff Member 3, and Child Care Staff Member 4 reported that they did not complete the sudden infant death and safe sleep practices before caring for infants and toddlers. There was no documentation to verify any trainings for the child care staff members. R 400.8131(3)	Child Care Staff Member 2, Child Care Staff Member 3, and Child Care Staff Member 4 reported that they did not complete the required training on prevention of shaken baby, abusive head trauma and child maltreatment, and recognition and reporting of child abuse and neglect. Child Care Staff Member 2, Child Care Staff Member 3, and Child Care Staff Member 4 were left unsupervised with children in their care. There was no documentation to verify any trainings for the child care staff members.
