II. Purpose of Addendum

The licensee has requested the following changes to the facility:

- Change in name from Farm Room 1 to the Garden Room.
- Change in name from Farm Room 2 to Farm Room.
- Combine the gross motor room and the Space Room to the Explorer room for children 18 months and older.

III. Methodology

IV. Description of Findings and Conclusions

Little Leaders Academy at Faith Baptist Church is located on the campus of Faith Baptist Church. The campus includes the church, school, and child care center.

The following rooms are approved for use:

Garden Room (previously Farm Room 1) measures 29.8 feet by 17.3 feet for a total of 516 square feet of usable child care space. The center partially removed a wall to add an additional 10 feet by 6 feet for 60 additional square feet of use space. The total square footage is now 576 square feet of usable child care space. This accommodates a capacity of 11 children birth to 30 months.

Farm Room (previously Farm Room 2) measures 29.8 feet by 17.5 feet for a total of 522 square feet. This accommodates a capacity of 10 children birth to 30 months.

The Jungle Room (previously Jungle Room 1) now measures 38.3 feet by 16 feet, 4 feet by 11 feet and 4 feet by 11 feet for a total of 701 square feet of usable child care space. The room was previously approved for infant/toddlers but will now be used for children over 30 months of age. This accommodates a capacity of 20 preschoolers. The licensee is aware that although the room can accommodate 20 preschoolers, the group size is based on the age of the youngest child in care.

The Forest Room (previously the Ocean Room) measures 24.9 feet by 15.3 feet and 16 feet by 13 feet for a total of 589 square feet. The room was previously approved for children over 30 months. The room will now be used by children ages 18-30 months. This accommodates a capacity of 12 children under 30 months of age. The licensee designee understands that if there is a mixed age group in this

room, the ratio and group size are based on the requirements of the youngest child in the room.

The Desert Room (previously Desert Room 1 and Desert Room 2) has been combined to make one room. The room now measures 34.5 feet by 29.3 feet for a total of 1011 square feet of usable child care space. This accommodates a capacity of 29 children over 30 months of age. The licensee designee understands that if there is a mixed age group in this room, the ratio and group size are based on the requirements of the youngest child in the room.

The Ocean Room (previously the Activity Room) measures 30.2 feet by 19.8 feet for a total of 598 square feet. This accommodates a capacity of 17 children over 30 months of age. The licensee designee understands that if there is a mixed age group in this room, the ratio and group size are based on the requirements of the youngest child in the room.

The following rooms are community use rooms that are approved for child care use, but not towards the center's overall capacity:

The infant nap room measures 10 feet by 24 feet and 16 feet by 5 feet for a total of 320 feet of usable child care space. The room capacity is 6 children birth to 30 months. The nap room is only equipped with cribs therefore, the room's capacity will not count towards the center's overall capacity. The licensee is aware that the nap room is a separate room from Farm 1 and children in the nap room must be supervised by a child care staff member in the room when children are in the nap room.

The Explorer Room (previously the infant/toddler gross motor room and the Space Room) will be used as a multipurpose room. The room now measures 42 feet by 30.4 feet for a total of 1277 square feet. This accommodates a capacity of 26 children under 30 months or 36 children over 30 months. The licensee designee understands that if there is a mixed age group in this room, the ratio and group size are based on the requirements of the youngest child in the room. Group sizes and ratio must be maintained at all times.

The Music Room (previously the Garden Room) measures 20.3 feet by 10 feet for a total of 203 square feet. This accommodates a capacity of 6 children over 30 months or 4 infants/toddlers. The licensee designee understands that if there is a mixed age group in this room, the ratio and group size are based on the requirements of the youngest child in the room.

The Art Room measures 20.3 feet by 14 feet for a total of 284 square feet. This accommodates a capacity of 8 children over 30 months or 6 infants/toddlers. The licensee designee understands that if there is a mixed age group in this room, the ratio and group size are based on the requirements of the youngest child in the room.

The Garden Room (previously the Music room) measures 20.3 feet by 9.8 feet for a total of 199 square feet. This accommodates a capacity of 6 children over 30 months or 4 infants/toddlers. The licensee designee understands that if there is a mixed age group in this room, that the ratio and group size are based on the requirements of the youngest child in the room.

Gross Motor Room measures 39.8 feet by 46.4 feet and 15.2 feet by 18 feet for a total of 2121 square feet. This accommodates a capacity of 61 children over 30 months and 42 infant/toddlers. The licensee designee understands that if there is a mixed age group in this room, that the ratio and group size are based on the requirements of the youngest child in the room.

The total center capacity is 99 children ages birth to 12 years. An equipment list was supplied and reviewed for the child care center.

There is an adequate supply of developmentally appropriate equipment, supplies and furniture for the center capacity of 99 children ages birth to 12 years.

There are 16 sinks, 10 toilets and 4 urinals available for children's use. The available toilets and sinks are sufficient for the capacity of 99.

Fire safety, environmental health and lead risk assessments were conducted at original issuance.

TERMS:

The center provides care to children ages birth to 12 years of age. The hours of operation are Monday through Friday from 6:30a.m. to 6:00p.m. The center will operate year-round. Full and part time care are offered. Before and after school care is also offered for school age children.


Transportation, swimming, and food service are not provided.

Parents must provide meals and snacks for their child.

V. Recommendation

I recommend approval of the following changes:

- Change in name from Farm Room 1 to the Garden Room.
- Change in name from Farm Room 2 to Farm Room.
- Combine the gross motor room and the Space Room to create the Explorer room for children 18 months and older.
