

R 400.8325(1) Sanitization.	Table were not washed, rinsed and sanitized before lunch.	Mrs. Jones will ensure that child care staff wash, rinse and sanitize tables before snacks and meals. Staff will be retrained.	04/07/2022 and ongoing.
R 400.8340(7) Food services and nutrition; provided by parents.	A carton of milk was not discarded or returned to parents 7 days after opening.	Mrs. Jones will ensure that milk is discarded or returned to parents 7 days after opening.	04/07/2022 and ongoing.

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
