This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 10/12/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

I observed parent drop off, free play, gross motor development, large circle time, snack time, quiet circle time, outdoor play and parent pick up. The facility was clean and well organized. Records were organized and readily available.

Technical assistance was given in reference to the following rules:
R400.8550 (4) Electrical service.
R400.8380 (5) Maintenance of premises
R400.8112 (2)(e)(f) Comprehensive background check: fingerprinting

The violations that were found are:

R 400.8131 Professional development requirements.

(11) Verification of all professional development required by this rule must be kept on file at the center or online at MiRegistry. Verification must be issued from the training organization or trainer and include the date of the course, the name of the training organization or trainer, the topic covered, and the

number of clock hours. Training hours from MiRegistry also meet this rule.

Staff records were reviewed onsite and three of four staff did not have verification of completion of Health and Safety 1 & 2 and were unable to produce verification of the required trainings.

On 10/12/2022, you gave us an acceptable written corrective action plan.
