Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

I observed staff sanitizing and organizing their rooms. I observed the classroom environment and required postings. I reviewed child records. I reviewed staff records. Records were readily available and organized. Programming for children had concluded the week prior to the inspection so programming with children will be observed upon resumption of classes in the fall.
