## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center's records, including staff records and children's records. Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

During the onsite inspection I was able to observe staff engaged in professional development activities. Classrooms were sanitized. Children were released for the summer and programming will be observed when classes resume in the fall. Records were readily available and organized.

**IV. RECOMMENDATION**

I recommend a regular license be issued to this child care center.
