During the onsite inspection I observed children transitioning between activities and outdoor play. I observed literacy related activities in large circle time. I observed handwashing, snack time and lunch. I observed sanitizing and toileting, I observed resting and napping children. I observed staff to be engaged with the children and to provide structure, redirection and soothing. The center is equipped with a variety of age-appropriate activities. Records were organized and readily available. It is evident that children are thriving in this environment.

As a result of the renewal inspection on 2/7/2023, I did not find any rule or law violations. You will receive your regular license in the mail.
