

III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care center administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of the center’s records, including staff records and children’s records. Staff records include background checks and training information. Children’s records include child information cards, physical examination dates, and immunizations.

During the inspection, the center was found to be in compliance with all applicable rules and statutes except for the following violations:

R 400.8143 Children's records.

(7) Physical evaluations must be updated as follows:

(a) Yearly for infants and toddlers.

(b) Every 2 years for preschoolers.

Five out of ten toddler physical evaluations were not updated as required.

R 400.8146 Information provided to parents.

(3) For infants and toddlers, a center shall provide parents with a written daily record that includes at least the following information:

(a) Food intake time, type of food, and amount eaten.

(b) Sleeping patterns indicating when and how long the child slept.

(c) Elimination patterns, including bowel movements, consistency, and frequency.

(d) Developmental milestones.

(e) Changes in the child's usual behaviors.

The center did not provide parents of Infants and Toddlers written daily records of their child's food intake, sleeping pattern etc, as required.

R 400.8335 Food services and nutrition; provided by center.

(5) Formula must be commercially prepared and ready-to-feed.

The center provides does not provide commercially prepared and ready to feed formula. During my onsite inspection child care staff members said they mix and prepare formula bottles onsite.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care center.
