### Approved Child Use Space:

Early Learning Center and Daycare is located inside State Line Christian School building located in Temperance, Michigan. The building is an active school building serving grades kindergarten through 12 grade. The center utilizes six rooms as approved child use space: Room 101 (game room serving children ages 2 ½ - 12), Room 102 (preschool/before/after school age serving children ages 2 ½ - 12), Room 103 (preschool serving children ages 2 ½ - 4), Room 104 (office – preschool/school-age overflow serving children ages 2 ½ - 12), Room 110 (art room serving children ages 2 ½ - 12), and gymnasium (large motor skills) which serves children ages 2 ½ - 12 years old.

The center offers both parttime and fulltime childcare, preschool, and before/after school programming Monday through Friday from 6:00 am until 6:00 pm, year round. The center provides a morning and afternoon snack for children. The parents provide breakfast and lunch for their children each day. The snacks provided for the children consists of fresh food and prepackaged food items that are in accordance with the Children and Adult Care Food Program requirements. Transportation is provided by the parents.

During my onsite inspection on 11/9/22, I observed the children during mealtime and small and large group activities. All the rooms were equipped with an adequate amount of age-appropriate play and learning equipment conducive to a childcare, preschool, and before/after care setting. The center provides the children with daily various

activities that include circle time, name and letter recognition, counting activities, music and reading instruction, and various arts and craft activities. Child care staff member interactions with children were positive and nurturing.
